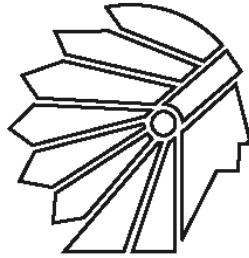

I further agree to save harmless and to reimburse the owners of **Oneida Campground & Lodge, LLC**. for any award or verdict for damages, as well as counsel fees it incurs, in connection with any suit or judgment which my result from said suit caused by my own actions or omissions. I understand that **Oneida Campground & Lodge, LLC**. is an "alternative" campground catering to gay and lesbian clientele and I am not offended by gay and lesbian patrons. I understand that **Oneida Campground & Lodge, LLC**. has no responsibility to inform any guests or visitors of the nature of its clientele.
